I certify that the products above are produced in accordance with all county, state and federal laws and grown or produced by myself and partners listed on this application. I understand that I am required to file all business entity changes, including changes in partners listed on business, with Springfield Farmers' Market immediately.**

**I agree to exercise the utmost care in the use of facilities and properties of Springfield Farmers' Market and City of Springfield. I understand that the premises used by the Springfield Farmers' Market are owned by the City of Springfield and are used with the owner's permission. Permission to use the premises can be withdrawn at any time. I agree not to hold Springfield Farmers' Market, NEDCO, or City of Springfield, its officers, directors, employees or agents responsible for any loss or damage claimed by the vendor should such permission be withdrawn.**

**This form must be signed, dated and returned to the Springfield Farmers' Market, along with a \$30 application fee (non-refundable) and required insurance documentation, before a vendor may sell at Springfield Farmers' Market.
